REQUESTING OUR SERVICES

Request for our services can be initiated by the patient and/or the patient's family, the patient's physician, or a hospital discharge coordinator. Home health care services will be initiated once the physician's orders are obtained. Individualized care plans are developed in conjunction with the Physician's orders and are based on the patient diagnosis, the availability of family support, and community services.
